Perlukah unit baharu tangani jenayah alam sekitar?

Adalah diharapkan penjelasan terperinci dapat diberikan kerajaan mengenai perubahan unit baharu bagi melindungi alam sekitar dan sumber negara daripada pencemaran.

Menyatakan Menteri Alam Sekitar dan Air, Tuan Ibrahim Tuan Man, berkata unit jenayah alam sekitar itu akan ditubuhkan dalam tempoh terdekat bagi menangani kegiatan haram yang mengancam sumber alam negara.

Langkah ini memperlihatkan usaha tegas ingin diambil kerajaan.

Namun, banyak soalan berlegar mengenai perubahan unit baharu ini terutama mengenai aspek fungsi dan perannya kelak.

Malah, ramai yang bertanya apakah perbezaan peranan bakal dimainkan unit baharu ini dengan agensi penguat kuasa alam sekitar sedia ada dalam negara kita seperti Jabatan Alam Sekitar (JAS)?

Di bawah agensi mana pula unit baharu ini akan diletakkan? Adalah terdapat percanggahan tugas antara unit baharu ini dengan penguat kuasa JAS? Kenapa tidak boleh diperkaskan JAS sahaja selaku agensi utama dalam negara kita yang diletakkan di bawah kementerian itu.

JAS ditugaskan untuk memantau pengaruh aktiviti berkaitan flora dan fauna dalam negara. Jabatan itu

sudah lama wujud serta memiliki banyak pengalaman dalam soal melindungi alam sekitar.

Pada awalnya diwujudkan sebagai Bahagian Alam Sekitar di bawah Kementerian Kerajaan Tempatan dan Alam Sekitar pada 15 April 1975.

Ia kemudian ditempatkan di bawah Kementerian Sains, Teknologi dan Alam Sekitar pada Mac 1976.

Berdasarkan kepentingan pemeliharaan dan pemuliharaan alam sekitar, tanggal 1 September 1983, Bahagian Alam Sekitar dinamikkan taraf ke sebuah jabatan sepenuhnya dan dikenali JAS.

Pada Mac 2004, ia dipindahkan di bawah Kementerian Sumber Asli dan Alam Sekitar.

Penubuhan Jabatan ini berdasarkan Akta Kualiti Alam Sekeling 1974 [Akta 127] yang diwartakan Mac 1974 dan dikuatkuasakan pada 15 April 1975.

Peranan utamanya untuk mencegah, menghapus, mengawal pencemaran dan memperbaiki alam sekeling, selaras segala peruntukan undang-undang yang ada di bawah Akta Kualiti Alam Sekeling 1974 (Akta 127) dan peraturan-peraturan di bawahnya.

Shah Alam: Kerajaan Selangor menggalakkan individu yang menjalankan perniagaan di hadapan rumah untuk memohon lesen sementara.

Pengerusi Jawatankuasa Pembangunan Usahawan, Pembangunan Luar Bandar, Desa dan

Kampung Tradisi negeri, Rodziah Ismail, berkata keputusan untuk memberikan lesen sementara itu dibuat berikutan ramai dilihat mencebur i bidang perniagaan bagi menampung kehidupan.

Sehubungan itu katanya, pihaknya mahu memudahkan dan membantu rakyat bermiaga di hadapan rumah, selain menggalakkan mereka bermiaga dengan bebas dan memiliki lesen.

"Bagaimanapun, mereka perlu mengikut syarat yang ditetapkan antaranya perlu mendapatkan suntikan (tifoid) dan menjaga kebersihan premis," katanya ketika dihubungi, di sini semalam.

Rodziah berkata, kaedah jualan bungkus dan balik (*take away*) sahaja dibenarkan, selain

peniaga tidak dibenarkan meletakkan meja serta kerusi untuk kegunaan pelanggan.

Katanya, pemberian lesen sementara itu juga akan membantu kerajaan negeri dalam segi statistik dan rekod peniaga yang berdaftar.

Rodziah berkata, lesen berkenaan boleh dimohon menerusi pihak berkuasa tempatan (PBT) masing-masing dan tarikh pembukaan permohonan akan diumumkan oleh Pengerusi Jawatankuasa Kerajaan Tempatan, Pengangkutan Awam dan Pembangunan Kampung Baru Selangor, Ng Sze Han, dalam masa terdekat.

Katanya, lesen berkenaan ber kemungkinan boleh mula digunakan bermula tahun hadapan.

Penduduk Selangor serik tanpa air

SAUDARA PENGARANG.

SERIK. Itu gambaran yang paling sesuai menggambarkan keadaan diri sendiri, keluarga dan jiran apabila empat hari tanpa air.

Banyak aktiviti yang dirancang pada ketika itu perlu dihadkan akibat ketiadaan air dalam tempoh yang lama menyebabkan majoriti penduduk di Selangor ketika itu lari ke negeri lain bagi meneruskan kehidupan harian ekoran pencemaran air mentah disyaki berpunca dari premis perindustrian di kawasan Sungai Gong, Rawang yang melakukan pelepasan berbau seakan pelarut ke dalam sungai.

Bukan itu sahaja. ‘Sakit mata’ apabila melihat warga emas dan kanak-kanak juga terpaksa mengangkut baldi serta botol air yang berat ke rumah masing-masing apabila bekalan air sampai ke lokasi perumahan.

Tindakan pantas polis menahan empat adik-beradik lelaki pemilik kilang yang disyaki terbabit dalam kejadian pencemaran air di kawasan perindustrian itu jelas membuktikan seriusnya isu ini kerana membabitkan 1.2 juta akaun pengguna di tujuh wilayah di sekitar Lembah Klang.

Minggu lalu, terdapat cadangan untuk mengklasifikasi kes pencemaran alam sekitar negara ini sebagai jenayah terancang supaya hukuman lebih berat dapat diambil di bawah Akta Kesalahan Keselamatan (Langkah-Langkah Khas) 2012 (SOSMA). Ia merupakan satu cadangan yang bernes sebagai pengajaran kepada pemilik kilang untuk lebih bertanggungjawab dalam menjalankan operasi perniagaan.

Begitu juga dengan tindakan Menteri Besar Selangor, Datuk Seri Amirudin Shari yang bertegas mahu semua kilang yang beroperasi tanpa kebenaran di tebing sungai di Selangor dirobohkan selari dengan titah Sultan Selangor, Sultan Sharafuddin Idris Shah.

Semoga pemilik kilang lebih peka terhadap alam sekitar dan tidak lagi mengulangi kesilapan sama dengan mengambil jalan singkat untuk membuang sisa kilang di dalam sungai.

Diharap rakyat terus menjadi mata dan telinga pihak polis dengan melaporkan kes-kes seumpama ini agar kegiatan haram yang dilakukan dapat dibanters sekali gus tindakan tegas dapat diambil kepada pemilik kilang.

Pantau Sungai Kim Kim elak pencemaran berulang

PASIR GUDANG - Operasi dan pemantauan secara berkala terhadap 274 kilang di sepanjang jajaran Sungai Kim Kim di sini perlu dilakukan berikutan pencemaran udara didakwa masih berlaku di daerah itu.

Pengerusi Sahabat Kanser Pasir Gudang, Zarina Abdullah berkata, pihak berkuasa antaranya Jabatan Alam Sekitar (JAS), Majlis Perbandaran Pasir Gudang (MPPG), Jabatan Pengairan dan Saliran (JPS), pihak industri serta pertubuhan bukan kerajaan (NGO) harus sentiasa melakukan pemeriksaan.

Menurutnya, pihaknya bimbang sekiranya pemantauan diaibaikan atau diambil mudah, pencemaran terbaharu Sungai Kim Kim akan berulang malah lebih teruk daripada sebelumnya.

“Kita dapati bau bahan kimia masih boleh dihidu pada sebelah pagi terutama di kawasan yang berdekatan industri. Ini perlu diberi perhatian dan tidak harus menunggu sehingga penemuan bahan sisa buangan baharu.

“Berdasarkan kajian, kesan menghidu bahan kimia akan diketahui dalam

tempoh lima atau enam tahun,” katanya kepada pemberita pada Majlis Pelancaran Badan Gabungan NGO Pasir Gudang di Taman Rinting di sini semalam.

Hadir sama Pengerusi Yayasan Pasir Gudang, Datuk Seri Mohamed Khalid Nordin.

Gelombang pertama pencemaran Sungai Kim Kim berlaku pada 7 Mac tahun lalu apabila pelajar di Sekolah Kebangsaan (SK) Taman Pasir Putih, Sekolah Menengah Kebangsaan (SMK) Pasir Putih dan Tadika Bestari mengalami pening kepala, loya, muntah dan pengsan.

Pada 11 Mac tahun lalu, gelombang kedua berlaku dikesan di dua sekolah tersebut sebelum keesokannya merebak. Keadaan bertambah parah apabila pelajar dari sembilan sekolah lain turut mengalami nasib yang sama.

Keadaan tersebut bertambah buruk dan Kementerian Pendidikan pada 13 Mac tahun lalu mengarahkan semua 111 sekolah di daerah itu ditutup diikuti semua institusi pengajian tinggi.

luarkan Jabatan Agama Islam Selangor (JAIS) mengenai pengurangan elaun membabitkan nazir dan timbalannya, setiausaha, bendahari, bilal serta siak daripada keseluruhan RM1,430 kepada RM880 tular di media sosial.

Dalam pada itu, Noh yang juga Ahli Parlimen Tanjung Karang berkata, tindakan Amirudin dalam soal perobohan kilang haram di negeri ini sehingga menyebabkan pencemaran Sungai Selangor turut dipersoal.



Septic and chemical waste discharged into retention pond in Kampung Sungai Manggis threatens to pollute Sungai Langat in Banting

CONTAMINATION of Sungai Langat in Banting is the latest issue that Selangor puts the recent wet and dry seasons under the scanner.

The black water is a result of septic and chemical waste being discharged into a retention pond in Kampung Sungai Manggis, located near the factory.

A check by StarMetro reveals that the water is indeed black, emitting a stench. Dark and foamy, it covers half the surface while aquatic plants had sprung up along the edges of the Sungai Langat through an older ground cover.

The pond is about 500m from the Kuala Langat Drainage and Irrigation Department office. Locals claim a nearby factory

workers' hostel was responsible for the foul discharge at the pond.

A few days ago, a month revealed that the hostel was discharging waste into the pond near the Tanah Rata hotel.

Resident Mohd Ali Hasan, 42, said local residents were worried that the continuous flow of polluted water into the pond may cause more contamination following the pollution incident.

"The discharge into the stream goes directly into the river and another water body," explained Hasan.

Deputy chairman of the Ar-Rahman committee secretary, Action Organisation (PTAKSI) chairman Tan Chon Yeng said he was shocked to find the water in Mahal Ali and a few other locals noticed a huge increase in liquid

sewage at the culvert.

"Perhaps those responsible

should be made to bear the

consequences."

He added that two samples were taken and sent to a laboratory in Shah Alam for analysis.

"One sample was taken at the pond and the other near the culvert," he said.

November last year. However, the number of complaints increased sharply by 2012 when works to install main pipes are conducted by Pengurusan Jalan dan Pemandu Selangor.

Klang council to monitor weekend high tide phenomenon with CCTVs

Traffic cameras to serve as early flood warning tool

MPK to monitor high tide in certain areas through its CCTV unit

CLOSED-circuit television cameras used for traffic management in Klang will double up as an early warning tool to detect rising water levels in low areas during this weekend's high tide phenomena.

Coastal areas in Selangor have been put on vigilant flood mode, as on Sept 19, the tide is forecasted to reach 5.7m at 7.16am while on Sept 20, the tide is expected to hit 5.6m at 7.53am.

Klang Municipal Council (MPK) Enforcement Department director Shahrul Hazri Abd Majid said the council's surveillance cameras would act as an early flood warning tool.

"Out of the 76 camera locations, we have five cameras in low-lying areas or flooding hotspots," he added.

"Our enforcement CCTV Unit staff will keep a keen eye for rising water levels.

"We will have real-time images from cameras at sites across Tanjung Harapan, Pulau Ketam jetty at Jalan Foreshore, Jalan Jambatan Connaught, Jalan Tepi Sungai and Menara MPK," said Shahrul, adding that the council's CCTV Unit staff would have a dual task.

"Our enforcement staff will keep an eye out for traffic and monitor the occurrence of flash floods," he explained.

"As soon as water levels rise, the unit will inform the council's Quick Action Team (Pantas), Klang Civil Defence Department and Port Klang Fire and Rescue Department."

Council president Dr Ahmad Fadzli Ahmad Tajuddin was glad that the CCTV Unit decided to turn a passive monitoring camera into a

visual sensor, which maximises the potential of the equipment.

"The unit's role is now much more important as they will mobilise the relevant authorities. Some cameras are in critical areas within a 5km radius of Sungai Klang," he said.

"Our aim is to utilise the camer-

as to warn residents of rising waters."

Fadzli added that even the Sluice Gate 38 at Jalan Tepi Sungai that controls high tide waters from breaching inland was monitored with cameras and sensors to automatically shut the gates.

Asked how MPK planned to warn people of rising waters, Fadzli said the council planned to upload information on water levels in real time on its Care website.

"Most people have smartphones so those who surf MPK's website will get updates on rising waters," he said.

Meanwhile, MPK Environmental Services Department director Zaireezal Ahmad Zainuddin said monsoon drains in flood-prone areas under the purview of the council were being desilted.

"Our in-house cleaning team has been cleaning up monsoon drains.

"On Sept 16, they cleaned the drain in Kampung Martin that runs behind SK Methodist ACS in Taman Melawis," he said.

Zaireezal added that the drain across D'Anjung neighbourhood, which bordered Taman Melawis, would also be cleaned to ensure smooth flow of water and prevent flash floods from occurring.

On the high-tide phenomenon expected to go into October and November with tides remaining high, Fadzli said the council would monitor the situation.

The high-risk flood areas in Klang identified by Selangor Disaster Management Unit are Kampung Tok Muda, Kampung Sungai Pinang in Pulau Indah, Pandamaran, Taman Selatan Damai, Port Klang, Kampung Sungai Serdang, Bund Sementa, Bund Sungai Keramat, Kampung Perepat, North Port, Telok Gong and Pulau Ketam.

Klang Fire and Rescue Department will monitor these areas too.

Residents in Klang can call MPK's Disaster Operations Room at 03-3370 1095 if they encounter difficulties during the high tide.

MPK holds clean-up at Taman Kem flats to curb dengue

KLANG Municipal Council (MPK) Commissioner of Buildings (COB) organised a weekend *gotong-royong* at the area surrounding five blocks of low-cost flats in Taman Kem, Port Klang, to curb the spread of dengue.

MPK COB director Hani Suryati Abd Rahman said around 80 residents participated in the half-day event that began at 8am and ended at 12.30pm.

MPK's Health Department also carried out fogging.

"People came together to clean

and remove rubbish dumped at road corners.

"Old tyres, plastic buckets and broken furniture left outside the flats were carted off," said Hani.

"We wanted to ensure that the immediate surroundings of the flats were not potential Aedes mosquito breeding sites.

"Two lorry loads of rubbish were removed from the area."

She added that residents were taught to identify breeding sites around the flats and eliminate areas of stagnant water where plastic bottles were strewn around.

Councillor for the area

M. Puspavali said the activity was timely in view of the dengue situation in Port Klang, where 563 confirmed dengue cases had been recorded from January to Sept 13.

Puspavali added that Taman Kem flats was chosen as the *gotong-royong* venue because there had been a number of dengue cases reported in the area.

MPK president Dr Ahmad Fadzli Ahmad Tajuddin, who was present at the event, said the council hoped to increase public awareness on the importance of dengue prevention within their surroundings in order to make the residential area safer for everyone.

Lawyers: Denial of bail in pollution case perplexing

PETALING JAYA: Lawyers are puzzled by the decision of the Selangor sessions court to deny bail for four directors and a manager who were charged in court on Tuesday over the pollution of Sungai Gong in Rawang.

Lawyer Datuk M. Reza Hassan, who is counsel for the four directors, all of whom are brothers, and the manager of Yip Chee Seng and Sons Sdn Bhd, told *theSun* yesterday that the sessions court had exercised its discretion in not granting bail but the decision is "highly unusual".

He said the prosecution had submitted that there was a risk of evidence-tampering in the case.

"They must furnish evidence of tampering. It

is quite perplexing as bail is merely to secure attendance in court and must not be used to deny a person's liberty while the court of law determines if he is guilty."

Reza said an appeal to seek bail for the five men is under way.

Two other lawyers shared similar opinions.

Lawyer Manoharan Malayalam said the offences are bailable and the decision to deny the accused bail is illegal.

"Why keep them locked up even before they are found guilty? Perhaps the court wants this to be a deterrent to other potential and similar offenders.

"However, this is illegal and cruel. It is a breach of fundamental rights which is enshrined in the Federal Constitution," he said.

"The Shah Alam High Court should intervene and call it up for a revision. The

accused are neither a flight risk due to the Covid-19 travel restrictions nor can they tamper with evidence or witnesses.

"While the public is the victim, the witnesses are made up of professionals who investigated the case. Moreover, how can they tamper with evidence when the workshop premise is sealed?"

Criminal lawyer K. A. Ramu said although the case is of public interest, the accused should have a right to bail as the law allows for it.

"Perhaps the presiding judge viewed the case as that of public interest, where millions of users were affected by a water cut. However, the prosecution should present a good reason as to why the accused should not be granted bail," he said.

The four brothers, Yip Kok Wai, 52, Yip Kok Mun, 58, Yip Kok Kuin, 50 and Yip Kok Weng,

60, were jointly charged with their company manager Ho Voon Leong, 59, for "discharging or depositing scheduled waste in the environment leading to pollution" under Section 25 of the Environment Quality Act and "mischief by injury to works of irrigation" under Section 430 of the Penal Code.

They were ordered to be held at the Bentong prison.

The men were held after large quantities of effluents suspected to have originated from their company were found dumped in Sungai Gong.

The effluents led to the pollution of the Sungai Selangor water treatment plant, which resulted in a major water cut in the Klang Valley that affected over 1.2 million households.

Apart from the directors and manager, other employees of the company were also probed.

No bail for alleged Sg Gong offenders

THE five men charged over the Sungai Gong pollution will await trial in prison as no bail was granted by the judge.

Selayang Sessions Court Judge Syafeera Mohd Said denied bail for the alleged offenders — the four company directors and a workshop manager, after hearing submissions from the prosecutors who said the case was unailable.

"This case caused six million residents in Malaysia to be without water supply for five days.

"This issue also received the attention of the country's leadership. If the court disagreed with my submission, I request the court to impose bail of RM2 million each," deputy public prosecutor Muhamad Iskandar Ahmad said at the court on Tuesday.

The five accused men are brothers Yip Kok Wai, 53; Yip Kok Mun, 58; Yip Kok Kuin, 70; and Yip Kok Wong, 60, who are the board of directors of Yip Chee Seng & Sons Sdn Bhd; and Ho Voon Leong, 59, who is the manager of the company's heavy machinery workshop.

Defence counsel Datuk M Reza Hassan appealed for a low bail, saying that his clients were cooperative during police investigations

and willingly surrendered themselves to the authorities after the incident occurred.

Another defence counsel, Abdul Rashid Ismail pleaded for RM100,000 bail, saying the clients are adults above the age of 50 who are at a higher risk of Covid-19 infection.

As it was, after hearing submissions by the prosecution and defence, Judge Syafeera denied all the accused bail.

Earlier, the five men pleaded not guilty to two charges.

One count is under Section 430 of the Penal Code for committing mischief by causing hazardous substances to flow from the workshop to Sungai Gong, causing a diminution of water supply for human consumption.

They were charged with committing the act at the workshop of Yip Chee Seng & Sons at Kg Sungai Dua, Rawang, in Gombak, Selangor, between Sept 2 and 3.

They face imprisonment for up to 30 years or a fine, or both, if convicted.

On the second count, they were accused of emitting environmentally hazardous substances from the workshop into a waterway, which then streamed into Sungai Gong, without a licence at the same place and time.

The offence falls under Section 25(1) of the Environmental Quality Act 1974 which provides a maximum fine of RM100,000, or imprisonment for up to five years, or both, if found guilty.

The Sungai Gong pollution wreaked havoc recently in the Klang Valley with unscheduled water cuts in Shah Alam, Petaling, Kuala Langat, Hulu Selangor, Kuala Selangor, Gombak and Kuala Lumpur.

Pengurusan Air Selangor Sdn Bhd had to shut down four water treatment plants, the Sungai Selangor Phase 1, 2 and 3 and Rantau Panjang water treatment plants, affecting over 1.2 million account holders. — by RAHIMI YUNUS
